**RESOLUTION AUTHORIZING THE SALE  
OF A PLENARY RETAIL CONSUMPTION LICENSE  
PERMITTING THE SALE OF ALCOHOLIC BEVERAGES IN THE  
TOWNSHIP OF TOMS RIVER, OCEAN COUNTY, NEW JERSEY**

**JANUARY 12, 2010**

WHEREAS, the Township of Toms River has the legal authority to issue a new plenary retail consumption license permitting the sale of alcoholic beverages; and

WHEREAS, the Township Council has determined to sell this plenary retail consumption license at a public sale; and

WHEREAS, , the Township of Toms River will accept bids for this license pursuant to N.J.S.A. 33:1-19.3;

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Toms River, in the County of Ocean, and State of New Jersey, as follows:

1. A new plenary consumption license for the sale of alcoholic beverages will be offered at a public sale in accordance with N.J.S.A. 33:1-19.3.

2. The Township Clerk shall publish a notice of the public sale of this plenary retail consumption license. The Public Notice is attached and incorporated in the Resolution.

3. The minimum bid price for this plenary retail consumption license is \$650,000.00. A deposit in the amount of 10% of the bid shall be submitted in cash, or by a cashiers, bank or certified check, with the bid proposal. The bidder whose bid is accepted shall, within 30 days after acceptance of the bid by the Township Council, submit the balance of the bid amount to the Township in cash, or by a cashiers, bank, or certified check.

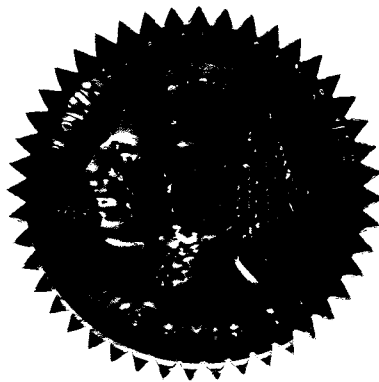
4. The Township reserves the right to reject any and all bids.


