2. Attached hereto is a written inventory of goods, wares and merchandise proposed to be sold. The inventory shows the cost price of each article therein and is signed and sworn to by the licensee or resident agent hereunto authorized. All articles in inventory are the regular stock of the the store or business being closed out by proposed sale. No replenishments or additions of goods, wares or merchandise, either preparatory to or during sale and licensed period, shall be permitted.

3. An accurate written record of all articles or things sold, showing prices at which each was sold, during sale and licensed period will be kept in or on licensed premises, during sale and delivered to Township Clerk within two days after expiration of licensed period so Township may ascertain the kind and quality or number sold.

4. Applicant certifies to Township of Dover that:

- (a.) applicant has been in business for at least one year prior to this application in Dover Township.
- (b.) proposed sale is to be conducted at licensee's bona fide retail establishment where applicant has been in business for at least a period of one year.
- (c.) no advertising for proposed sale has been or will be done prior to getting license and filing inventory.
- (d.) proposed licensed premises are known as Lot....., Block..... on Dover Township Tax Map. Said premises are located at No.....Street....., Dover Township.

Said premises are safe for holding proposed sale and proper precautions have been taken by applicant to protect prospective customers and general public in attending proposed sale.
